**Primary Club Issues**

Also note, that if the Hunter’s NRPC as your ONLY Club, then we are automatically your Primary Club.

Note also that the Primary Club takes the responsibility for signing you off each year under the agreed NRA / MOD rules as a safe shot. Thus, ALL Hunter’s NRPC members will need to satisfy the Club Committee that they have undertaken basic safety training to the requisite standard determined by the Hunter’s NRPC Committee.
